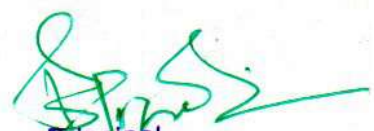

NOTES FORMING PART OF ACCOUNT

1. Books of Accounts :

The management of the college followed the mercantile basis of accounting policies for preparation of its financial statements.

2. Grants received from Directorate of Public instruction, Education Directorate, West Bengal have been utilized for the purpose for which the same was sanctioned.

3. There is no arrear short deposit against assumed income as defined in Section 2(b) of the West Bengal Colleges (Payment of Salaries) Act, 1978.

4. Books of accounts are to be properly maintained reflecting opening and closing balances. The opening cash balance on 14.12.2021 as verified was Rs. 48015

5. The expenditures are not reflecting the total available fund therefore as balance sheet of previous year does not reflect the opening balances properly so the prior period adjustments are made in drawing up the accounts properly.

6. The fund accounts did not reflect the financial position of the accounts as the utilization of funds are not shown in the respective fund accounts resulting continuous increasing of the balances of the respective fund balances without having any parity of the available fund in the balance sheet now that has been rectified as prior period adjustment.

7. The furnitures head includes so many items those should be segregated as all items are not furnitures.
