- 14) Interested agencies are required to quote the rate in figure as well as in words mentioning percentage above/ below or AT PAR on the basis of relevant price schedule of probable items with approximate quantities.
- 15) Contractors shall have to comply with the provisions of (a) the contract Labour (Regulation Abolition) Act, 1970 (b) Apprentice Act 1961 and (c) Minimum Wages Act, 1948 or the modification there or any other laws relating thereto and the rules and order issued there under from time to time.
