Sub: Information regarding non-Payment of fund to the beneficiary of Kanyashree Prakalpa scheme.

With reference to the above, this has come to know that there are some beneficiaries for whom the fund related to Kanyashree Prakalpa (K1 and K2) is still not credited in the account of the beneficiary, though a considerable time has already been elapsed. Perhaps such beneficiaries had approached the school or anywhere but the problem is not solved yet. The reasons behind such cases of non-payment may be due to payment failure, HOI not paying timely and proper attention for editing in portal, limitation of the portal etc.

Also from this end it is not clear how many cases of such non-payment of Kanyashree fund in the account of beneficiaries are still pending from the financial year 2017-18 to 2022-2023 as there is no system for generating such MIS from the portal, for identifying such beneficiaries, a field level information, mainly from the school is urgently and earnestly required.

Now, in view of the above, I am to request you to take initiative in the matter and to identify and collect school wise and year wise list of beneficiaries (if any) with name, address, ID and contact no. with due amount along with copies of the relevant pages of the passbook from all HOIs for whom till date no payment has been made. During finalisation of the list the Passbook of the account of the beneficiary is to be checked meticulously to avoid any chance of multiple payments to any beneficiary.

Now, you are requested to arrange for collection and to send the list (in excel and PDF) through your Nodal Officer and AI/SI of schools, to this end by 06/09/2024. After availability of the municipality and block wise, year wise and school wise list duly signed by the HOI and SI/AI of schools with countersignature from your end, the necessary action will be taken from this end.
